IFFSC Membership Agreement 2024-2025

I recognize that my/my minor child's participation in all skating activities, supported or sponsored by the Idaho Falls Skating Club ("IFFSC" or the "Club") is an honor and a privilege. The Club reserves the right to refuse or terminate any membership. On behalf of myself/my minor child, I agree to fully abide by the rules and guidelines set forth by the IFFSC and US Figure Skating. I will exhibit a model of behavior that will provide a good example to the community and encourage pride in our Club. I will display proper respect and sportsmanship to fellow members, coaches, officials, parents and skaters in the club as well as rink management and staff.

• Agreement to Follow IFFSC and USFS Rules

I hereby agree to abide by the bylaws, rules, policies and Parents Code of Conduct of the IFFSC and US Figure Skating listed at <https://www.idahofallsfsc.org> and <https://www.usfigureskating.org>, I understand that failure to do so may result in termination of membership.

• Press Policy

I understand that all press submissions concerning figure skating must be made through IFFSC. I understand that direct press submissions, or submissions solicited from others on my behalf, constitute a IFFSC rule violation.

• Volunteer Requirements

I understand that the IFFSC relies heavily upon the volunteer support of all its members. Minimum volunteer requirements for each family of a IFFSC member are 10 hours of service to the club during any of its annual events. IFFSC requests all adult members, skaters age 12 and older, and parent/guardian for each junior skater to volunteer in some capacity at the Skate River Skatefest, either during the event or beforehand.

****Fundraising Requirement (NEW)****

I understand that each family who has a skater/skaters in the club is required to fundraise at least \$500.00 total for the club via fundraisers or direct donations. This counts money directly going to the club. For example: a \$1.00 candy bar sale of which \$0.50 goes to the club counts as \$0.50 towards the skater's fundraiser requirement. A post dated check for \$500.00 is due upon membership registration. The check will be cashed at the end of the season if the skater does not fulfil the fundraising requirement. Any fundraising amount from a family lower than \$500.00 will be returned upon deposit of the \$500 check at the end of the season. The Club will provide at least two fundraising opportunities: October Calander (\$492 if the entire calendar is filled) and sale of Town and Country Gift cards. Members are welcome to raise funds any way they choose and additional fundraising ideas are always welcome.

• Club Jacket Requirement

All junior competitive members representing the IFFSC at competitions and test sessions are encouraged to wear IFFSC jackets.

• Acceptance of Terms

I have read the above requirements, completed the application, and waiver and have attached payment. The IFFSC reserves the right to refuse or cancel any membership.

Idaho Falls FSC Waiver and Release of Liability

In consideration of participating in the Idaho Falls Figure Skating Club (hereafter "IFFSC," or "Club") activities, I represent that I understand the nature of figure skating activities ("activity") and that I am qualified, in good health and in proper physical condition to participate in such "activity". I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the "activity". I fully understand that this "activity" involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the "activity", the conditions in which the "activity" takes place, or the negligence of the "releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the "activity". I hereby release, discharge, and covenant not to sue the IFFSC , United States Figure Skating, it's directors, officers, administrators, sponsors, volunteers, agents, employees, staff, instructors, trainers, other participants and if applicable, owners and lessors of premises on which the "activity" takes place (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the releasees from any loss, liability, damage, or cost which any may incur as the result of such claim. The IFFSC has the right, but not the obligation, to provide rules, regulations and/or ice monitors for Club Ice. We hereby acknowledge that the IFFSC shall not be responsible for the supervision of the members at any time, including, but not limited to Club Ice. I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it conditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, not withstanding, shall continue in full force and effect.
